**AMENDED ORDER REMANDING CASES FOR FURTHER PROCEEDINGS
IN THE DISTRICT COURT**

COMES NOW the Supreme Court of the Cherokee Nation, and, after examining the petitions of the above referred to transferred cases from the District Court of the Cherokee Nation, and, examining the Order of Transfer entered by the Honorable John Cripps dated April 13, 2007 and filed in this Court on April 17, 2007, makes the following order remanding the cases for full adjudication of the cases by the District Court under the following directions:

1. The District Court shall grant the individual petitioners *de novo reviews* of the decisions of the Registration Committee as mandated by Article IV, Section 2(c) of the 1999 Constitution of the Cherokee Nation and 11 CNCA 1992 Section 27, and the Court shall consolidate those cases that are identical in complaint of facts and law.

IT IS THEREFORE ORDERED by the Court that all the above shall be the Court's order.
